**The Division – About our city:** Harrisonburg is located in the heart of the Shenandoah Valley with the Blue Ridge Mountains on the east and the Allegheny Mountains on the west. Harrisonburg is within a two-hour drive of Washington, DC and the cities of Richmond, Charlottesville, and Roanoke, Virginia. It is currently among the fastest growing cities in the state with a population of over 50,000. Harrisonburg is proud to have two universities within a five-mile radius of the city. Harrisonburg offers a wide variety of activities for art and history lovers as well as outdoor enthusiasts. Harrisonburg offers residents and visitors a rich historical and cultural experience, a plethora of ethnic dining options, and an abundance of outdoor activities. Harrisonburg is also known for its vibrant downtown, 19th century architecture, bike-friendly streets, family-friendly museums, innovative dining spots, and locally-owned shops.
